ii). The vehicle presently available for Senior Civil Judge-cum-Magistrate at the station shall remain with the Senior Civil Judge (Administration).

iii). The Administrative Senior Civil Judges, appointed in the Districts, shall also act as officers of the Directorate and shall regularly furnish information and reports as required by the Director General, Directorate of District Judiciary, Lahore High Court, Lahore through the respective District & Sessions Judges.

Allocation of work:

- **Senior Civil Judge (Administration):**
