No. 158 /RHC/CJJ/B-30, Dated Lahore, the 21st June, 2018.

In continuation of this Court's Notification No.152/RHC/CJJ/B-30, dated 11.06.2018, in exercise of the powers conferred by Rule 4 of the Punjab Judicial Service Rules, 1994, and by virtue of judgment of the Hon'ble Supreme Court of Pakistan in case titled Province of Sindh through Chief Secretary and another Vs. Rasheed A. Rizvi and others (PLD 2012 Supreme Court 649), the Hon'ble Chief Justice and Judges, on recommendations of the Hon'ble Examination Committee and after fulfillment of all codal, just and legal formalities as well as clearance of medical examination required under Rule 3.2 of C.S.R. (Punjab) Vol-I, are pleased to appoint following recommendee as Civil Judge-cum-Magistrate (BS-17) in the Punjab, with effect from the date he assumes charge of the post, on the terms and conditions given below:-

TERMS AND CONDITIONS:-

- i. The appointee shall maintain his inter-se seniority as per recommendations of the Hon'ble Examination Committee.
- ii. The appointee shall be governed by the Punjab Civil Servants Act, 1974, the Rules framed there under including the Punjab Judicial Service Rules, 1994 and such other rules/instructions which are applicable to the Civil Servants/Judicial Service as made applicable to them from time to time.
- iii. The appointment is purely temporary and the services can be terminated during probation without notice and without assigning any reason.
- iv. The appointee shall remain on probation for such period as prescribed by the Punjab Judicial Service Rules, 1994, but shall have no right of confirmation after the expiry of this period unless permanent vacancy becomes available and he is otherwise eligible for confirmation as well but subject to his passing the prescribed Departmental Examination and qualifying such course and training as may be determined by the High Court.
- v. One month's notice or in lieu thereof one month's pay is necessary for resignation by the appointee.
- vi. If any degree/certificate of academic qualification submitted by the appointee is subsequently found by the competent authority to be bogus/forged, etc., or the appointee is found involved in a criminal case, or he furnishes incorrect information required from him, he shall forfeit his

right to continue in service, and legal action, as determined by the authority, shall be taken against him.

This offer holds good until **25.06.2018**. In case the offer is acceptable to the appointee, he should report to the office of undersigned on or before the said date. After submission of acceptance he shall report to the office of undersigned on **26.06.2018** at **11:30 a.m.** to take oath of his office.
